



18. Bidder/its OEM Should Have valid ISO 9001,14001 & 45001 certification.
19. Bidder/its OEM Should Have GC mark certification.
20. Bidder/its OEM may have similar work credentials in educational institutes will be added advantage.


38. Escalation of Price on any ground and consequent cost overrun shall not be entertained under any circumstances. Rates should be quoted accordingly.
